The New Jersey Meadowlands Commission (NJMC) offers guided canoe trips of wildlife management areas throughout the Meadowlands. These fun and educational trips are an excellent way to see the natural beauty of the Meadowlands and its wildlife up-close.

All locations offer amazing diversity in vegetation and wildlife, as well as a rich history. You will learn about the basics of salt marsh ecology and enjoy the magnificent natural and man-made scenery as you paddle down streams and creeks.

Trips last approximately 3 hours and are for ages 10 and up. The NJMC provides all equipment and gives basic safety tips before each trip. Each canoe holds up to 3 people, and it is preferred that at least 1 person has experience in canoeing. Cost is \$15 per person. Pre-registration required. Trips are fully insured by the NJMC.

Due to the overwhelming response to our canoe trips, reservations cannot be held until we receive your registration form and check or cash payment. We do not accept credit card payments. A confirmation letter and directions to the launch site will be mailed to you once we receive your payment.
